A minimum score of 70 points out of 100 must be scored for Functionality. Bidders, who do not obtain the minimum score for functionality, will not be considered for further evaluation.

SUPPLIERS/SERVICE PROVIDERS SHALL TAKE NOTE OF THE FOLLOWING BID CONDITIONS:

- [g] For all transactions exceeding R15 000, a Central Supplier Database report must be provided showing tax compliance.
- [h] This Quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the **Preferential Procurement Regulation of 2011** and for this purpose the service providers are required to submit together with their quotation the **Original and valid B-BBEE Status Level Verification Certificate** or **certified** copies thereof.
