5. Certified or Original BBBEE Certificate
6. Company Profile
7. Cancelled Cheque / Confirmation Letter from the Bank
8. Original or Certified Municipal Billing Clearance (**NOT OLDER THAN 30 DAYS**)

9. Only Original Registration Forms will be accepted.

All service providers or suppliers who were previously or are currently providing services or supplies to Blue Crane Route Local Municipality MUST also re-register as they will not be automatically included in the database.
