### T1.1 : TENDER NOTICE AND INVITATION TO TENDER

The Blue Crane Route Municipality invites tenders for the *Upgrading of Sportsfield in Khanyiso, Pearston*.

*The work involves construction of a grassed soccer field with associated sub surface drainage, irrigation pump station, irrigation pipeline and fencing.*

It is estimated that Tenderers should have a CIDB contractor grading designation of **3CE, or higher**.

This tender will be evaluated according to points awarded for price and B-BBEE Status Level of Contribution. The 90/10 Preference Point System will be applied to this tender. Tenderers will also be required to meet functionality criteria in order to be considered for award. Documents may be collected during working hours after 08:00 at the offices of the Blue Crane Route Municipality, 67 Nojoli Street, Somerset East on **Thursday, 01 October 2015**. A non-refundable tender deposit of R350, *three hundred and fifty rand*, is required and payable prior to collection of the tender documents. The Blue Crane Route Municipality offices in Somerset East are open Mondays to Fridays from 08h00 to 16h30.

Cheques shall be crossed and made payable to the Blue Crane Route Municipality.

A compulsory clarification meeting with representatives of the Employer and the Engineer will take place at **the Town Hall, Somerset East on Friday 09 October 2015** commencing at **10:00**.

The closing time for receipt of tenders is **12:00 on Friday, 23 October 2015**.
