<b>T1.1 : TENDER NOTICE AND INVITATION TO TENDER</b>

The Blue Crane Route Municipality invites tenders for the *Upgrading of Sportsfield in Bhongweni, Cookhouse*.

*The work involves construction of a grassed soccer field with associated sub surface drainage, irrigation pump station, irrigation pipelines, spectator seating and fencing.*

It is estimated that Tenderers should have a CIDB contractor grading designation of 4CE, or higher.

This tender will be evaluated according to points awarded for price and B-BBEE Status Level of Contribution. The 90/10 Preference Point System will be applied to this tender. Tenderers will also be required to meet functionality criteria in order to be considered for award.

Documents may be collected during working hours after 09:00 at the offices of the Blue Crane Route Municipality, 67 Nojoli Street, Somerset East on Monday 11 January 2016. A non-refundable tender deposit of R350, *three hundred and fifty rand*, is required and payable prior to collection of the tender documents. The Blue Crane Route Municipality offices in Somerset East are open Mondays to Fridays from 08h00 to 16h30.

Cheques shall be crossed and made payable to the Blue Crane Route Municipality.

A compulsory clarification meeting with representatives of the Employer and the Engineer will take place at the Town Hall, Somerset East on Tuesday 19 January 2016 commencing at 10:00. Note that after 10:10 no further tenderers will be permitted to attend the meeting. Also, no attendee will be permitted to leave the meeting before it is declared closed.

The closing time for receipt of tenders is 12:00 on Monday 01 February 2016. Tenders must be enclosed in sealed envelopes, bearing the applicable tender heading and reference number, as well as the closing time and due date.

<p>Tenders must be submitted in the TENDER BOX situated at Corporate Services Building (opposite ABSA Bank) 88 Nojoli Street, Somerset East. Tenders will be publicly opened simultaneously at the latter addresses at the time indicated. A tender must remain valid for a period of 16 weeks from the closing date for the submission of tenders. The lowest or any tender will not necessarily be accepted, and the Municipality reserves the right to accept a tender as a whole or in part. Telegraphic, telephonic, telex, facsimile, e-mail, posted and late tenders will not be accepted. Tenders may only be submitted on the tender documentation that is issued. More requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data.
