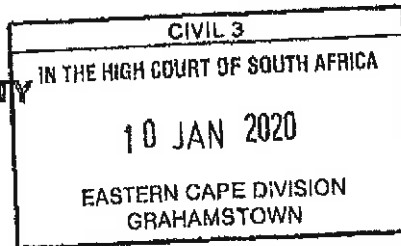

NOTICE OF MOTION

TAKE NOTICE THAT the Applicant intends to make application to the above Honourable Court for orders in the following terms:

1. That service of the main application be effected on the Respondents In terms of Rule 4 (2) of the Uniform Rules of Court by substituted service in the following manner:-

1.1. By service by the Sheriff of the High Court on Messrs A and R Attorneys of Somerset East and RJM Attorneys Inc. of Walmer, Port Elizabeth of a copy of the Notice of Motion and annexures.

- 1.2. By two publications of the Notice of Motion only in the "*Hartland*" newspaper.
 - 1.3. By service of the Notice of Motion only on those Further Respondents whose emails are known to the Applicant Municipality with a notification that the Founding Affidavit and annexures may, be obtained (upon request) from the Applicant's Attorneys.
 - 1.4. By the inclusion of the Notice of Motion only in the Municipal rates and service accounts addressed to the Further Respondents accompanied by a notification of the nature referred to in paragraph 1.3 above.
 - 1.5. By affixing a copy of the Notice of Motion (without annexures) to the notice boards at all Municipal offices of the Applicant.
2. At the hearing of the main relief to be sought in this application, the Applicant will seek orders in the following terms:
- 2.1. That (subject to any process of objection and/or appeal lawfully initiated as set out in Chapter 6 of the Property Rates Act, Act 6 of 2004) the Further Respondents are obliged to pay to the Applicant the rates and other service charges raised by the Applicant in respect of the immovable properties owned by the Further Respondent in terms of the rates policy and rates bylaw of the Applicant for the financial year 2019/2020.

- 2.2. That the Further Respondents are not lawfully entitled to withhold payment of the aforesaid rates and service charges.
- 2.3. That the Further Respondents are liable to pay legal interest upon any arrear rates and services amounts due by the Further Respondents to the Applicant.
- 2.4. That it be further declared that the Applicant is entitled to institute debt recovery proceedings, pursuant to its debt recovery processes, for recovery of all overdue rates and service charges, due by the Further Respondents.
- 2.5. That such Respondents which oppose the main relief sought in this application (as set out in paragraph 2 of the Notice of Motion) be ordered to pay the costs occasioned by this application, jointly and severally, the one paying the others to be absolved, and such costs to include the costs occasioned by the employment of two counsel.
- 2.6. Further and/or alternative relief.

TAKE NOTICE FURTHER THAT the accompanying affidavits of the Municipal Manager and Chief Financial Officer of the Applicant will be used in support of this application.

TAKE NOTICE FURTHER THAT the Applicant has appointed as the address at which it will accept notice and service of all process in these proceedings that of

NETTELTONS, Attorneys of 118A High Street, Grahamstown.

TAKE NOTICE FURTHER THAT in respect of the main application for the relief set out in paragraph 2 above, the Applicant will seek a further order that the main application, be heard as a matter of semi-urgency and that non-compliance with the Rules of the above Honourable Court, with regard to form and service, be condoned insofar as it may be necessary to do so. The grounds for such urgency are set out in the affidavits filed in support of this application.

TAKE NOTICE FURTHER THAT the order for directions as to substituted service, set out more fully in paragraph 1 above, will be and is hereby set down for hearing before the above Honourable Court, on an *ex parte* basis in (unopposed) Motion Court on **TUESDAY, 14th of JANUARY 2020 at 09h30** or as soon thereafter as the matter may be heard.

TAKE NOTICE FURTHER THAT, thereafter, the main application for the relief sought in paragraph 2 above, will be set down, on a semi-urgent basis (subject to the directions of the above Honourable Court) on a date assigned by the Registrar and upon notice to the parties' (or their legal representatives) who oppose the application.

TAKE NOTICE FURTHER THAT if any of the Respondents intend opposing the main application, such Respondent or Respondents is / are required to:-

- a) notify the Applicant's attorneys of record at the address set out hereunder in writing within FIVE (05) days of service of the application papers in the manner directed on the Respondents of their intention so to do;

b) and within fifteen (15) days after they have so given notice of their intention to oppose the application, to file answering affidavits if any; and further that they are required to appoint in such notification an address referred to in Rule 6(5)(b) at which such Respondents will accept notice and service of all documents in these proceedings.

TAKE NOTICE FURTHER THAT if no such intention to oppose be given, the main application will be set down, as aforesaid, on a date assigned by the Registrar and again, subject to such directions (if any) as the above Honourable Court may furnish.
