BIDDERS MUST TAKE NOTE OF THE FOLLOWING BID CONDITIONS:

- The Blue Crane Route Municipality Supply Chain Management Policy will apply.
- In order to claim Preference points a valid original or an original certified copy of B-BBEE Status Level Verification Certificate from a SANAS registered verification agency or EME's to submit a sworn affidavit signed by the EME representative and attested by Commissioner of oaths to validate the claim, No B-BBEE Status Level Verification Certificate – No points to be allocated.
- Bidders should be registered on the Central Supplier Database with a Tax Compliant Status.
- Bidders are to submit Municipal Billing Clearance from their local municipality as per section 1.2.8.2.
- Failure to complete all tender forms, data sheets and submit all supplementary information will lead to the bid being considered non-responsive.
- Bids that are received after the specified time and date, incomplete, not completed in black ink, unsigned or submitted by facsimile or electronically will not be considered.
- Bids submitted must indicate a 90 days price validity period.
- The Blue Crane Route Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid.
